A RESOLUTION APPROVING RENEWAL OF AMBULANCE LICENSE AND AMBULANCE VEHICLE PERMITS FOR THE SUMMIT COUNTY AMBULANCE SERVICE.

WHEREAS, pursuant to the authority granted in the Colorado Emergency Medical Services Act, C.R.S., 25-3.5-101, et seq., as amended (the "Act"), and the State Board of Health Rules Pertaining to Emergency Medical Services 6 CCR 1015-3 (the "Rules"), the Board of County Commissioners of Summit County, Colorado, are authorized to adopt revised Summit County Emergency Medical Services Rules and Regulations; and

WHEREAS, the Board of County Commissioners of Summit County, Colorado ("BOCC") adopted the "Emergency Medical Service Rules and Regulations for Summit County, Colorado" on March 27, 2012 by Resolution No. 2012-19 (the "County EMS Regulations"); and

WHEREAS, the Summit County Ambulance Service ("SCAS") submitted an application dated July 8, 2019 to the BOCC for renewal of its ambulance license and ambulance vehicle permits pursuant to County EMS Regulations (the "Application"); and

WHEREAS, the BOCC considered the Application in accordance with applicable provisions of the County EMS Regulations and the BOCC determined that approval of the Application for renewal of the SCAS ambulance license and vehicle permits would not adversely affect the then existing EMS System, as such term is defined in the County EMS Regulations; and

WHEREAS, in making its determination to approve the Application, the BOCC specifically considered the criteria provided in County EMS Regulations Sections 3.12.1 through 3.12.4, and the BOCC specifically finds in accordance with County EMS Regulations 3.13.1 through 3.13.3 that Applicant's equipment and vehicles comply with the applicable provisions of the current E.M.S. Act and Colorado Department of Public Health and Environment rules pertaining to Ambulances, that Applicant's equipment and vehicles comply with the requirements of the County EMS Regulations, and that the Applicant has complied in all respects with the requirements of the County EMS Regulations; and

WHEREAS, the BOCC finds that it is in the best interest of the public health, safety and welfare of citizens and visitors of Summit County to approve renewal of the SCAS Application for Licensure.

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF SUMMIT, STATE OF COLORADO HEREBY APPROVE RENEWAL OF THE SUMMIT COUNTY AMBULANCE SERVICE AMBULANCE LICENSE AND AMBULANCE VEHICLE PERMITS, AS DESCRIBED IN THE ATTACHED AND HEREBY INCORPORATED SUMMIT COUNTY AMBULANCE SERVICE APPLICATION FOR LICENSURE DATED JUNE 26, 2018.
