SUMMARY MINUTES**

I. CALL TO ORDER

The second meeting of the County Board of Equalization on Tuesday, September 1, 2020, was called to order by Chair, Karn Stiegelmeier, at 1:25 p.m. in the County Commissioners' Meeting Room; Summit County Courthouse, 208 East Lincoln Avenue, Breckenridge, Colorado.

II. ROLL CALL

III. APPROVAL OF AGENDA

The Agenda was approved, as presented.

IV. CONSENT AGENDA

- A. Approval of Minutes from the August 5, 2019 meeting of the County Board of Equalization. **Approved as presented; and**

V. NEW BUSINESS

- A. Assessor's Report of Valuation of Assessment of All Taxable Real Property in Summit County for Tax Year 2020 (Assessor).

Frank Celico presented the Assessor's Report of Valuation for All Taxable Real Property and noted the change of dates for 2020, due to the Governor's orders extending taxpayer filing deadlines due to COVID-19. He also noted that 2020 is not an assessing year. The Assessor's Office received 256 real property protests, denied 163, and 4 hearings are scheduled for September 24th.

MOTION: A motion was made by Commissioner Davidson and seconded by Commissioner Lawrence to accept the Assessor's Report of Valuation of Assessment of All Taxable Real Property in Summit County for Tax Year 2020, as presented.

MOTION PASSED UNANIMOUSLY BY THE BOARD PRESENT

B. Assessor's Report of Valuation of Assessment of All Taxable Personal Property in Summit County for Tax Year 2020 (Assessor).

Mr. Celico noted that unlike real property, personal property is re-valued each year. He also stated that the Assessor's Office will send out personal property notices on September 2nd.

MOTION: A motion was made by Commissioner Lawrence and seconded by Commissioner Davidson to accept the Assessor's Report of Valuation of Assessment of All Taxable Personal Property in Summit County for Tax Year 2020, as presented.
