**BOARD OF COUNTY COMMISSIONERS

**APPROVING THE CREATION OF A COUNTY DISPOSAL DISTRICT AS WELL AS THE
CERTIFIED DISPOSAL DISTRICT PLAN AND DISPOSAL DISTRICT REGULATIONS**

WHEREAS, the Summit County Board of County Commissioners is authorized by C.R.S. § 30-20-201 *et seq.* to establish a disposal district to serve a public use and to promote the health, safety, prosperity, security and general welfare of the inhabitants of the district; and

WHEREAS, the Board has received from the Summit County Board of Health, a certified plan for the formation of a Summit County Disposal District (“Disposal District”); and

WHEREAS, as provided by law, the Board has caused to be published notice of public hearing regarding formation of the disposal district on at least three successive weeks in a newspaper of general circulation in Summit County; and

WHEREAS, the Board held the noticed public hearing concerning formation of the Disposal District and took testimony and other evidence offered by the public; and

WHEREAS, after hearing testimony, considering evidence and evaluation the certified plan, it is the desire of the Board to form the Disposal District and approve of the Disposal District Plan, which the Board finds to be reasonable and necessary and further determines such formation and plan will serve a public use and will promote the health, safety, prosperity, security and general welfare of the inhabitants of the disposal district.

NOW, THEREFORE, BE IT RESOLVED that the Summit County Board of County Commissioners:

1. Hereby creates the Summit County Disposal District pursuant to C.R.S. § 30-20-201, *et seq.* which shall exist in all the unincorporated areas of the County, for the disposal of waste, trash and garbage within Summit County as provided for in the Disposal District Plan, as certified by the Summit County Board of Health.
2. The Disposal District Regulations, attached as Exhibit A to the Disposal District Plan, are hereby approved as presented. The Disposal District may establish such other rules and regulations as may be deemed reasonably necessary for the administration of the Disposal District or to accomplish the goals, policies and objectives of the Disposal District.

3. The services for and the purpose of the Disposal District can best be provided by the establishment of the Disposal District on a county-wide basis, excluding incorporated territory and other exclusions required by statute.
