Dan Hendershott gave an update regarding guidance for short-term rentals including a 24 hour wait on cleaning and asking owners to keep a log of all guests that stay at the unit.

Commissioners and staff discussed how to get guidance documents to short-term rental permit holders and businesses. The documents are available on Summit County's website.

Amy Wineland gave an update on testing for COVID-19. She noted that it is available seven days per week. Public Health is recommending that asymptomatic individuals who have had close contact with people who have tested positive take a test seven days after that contact. She also noted that the definition of "close contact" has changed from spending ten minutes to spending fifteen minutes within six feet of an individual who has tested positive.

**Review of the ongoing Public Health COVID-19 Local Disaster Emergency and the Legal Issues related thereto (Public Health Dept., Attorney).**

A motion was made by Commissioner Davidson and seconded by Commissioner Lawrence to go into Executive Session to review confidential public health, information, investigations, and other issues pertaining to the ongoing COVID-19 Local Disaster Emergency, and the Legal Issues related. BOCC voted 3 to 0 to go into Executive Session per CRS 24-6-402 (4) (b)(c)(d) with specific reference to 25-1-122. The motion was approved.
