**SCALE PROCEDURE**

All vehicles should stop before the scale approach, and then proceed slowly. Please pull off scale slowly until you are clear.

Allow the vehicle in front of you to pull completely off the scale before pulling on. If you have a red light, wait until you get the green light. In order to get accurate weights, the scale needs to zero out between vehicles.

Do not shift gears on the scale or come to an abrupt halt. Sudden jerks to the scale can either throw off the calibration or actually damage the scale mechanism.

**ALL LOADS MUST BE COVERED – DOUBLE CHARGE FOR UNCOVERED LOADS**

Accepted payment – cash or check with proper id – credit cards accepted. There is a 75 cent charge & 2.25% convenience fee added to your total to pay with credit or debit card.

Speed limit throughout landfill 14.5 mph. Landfill equipment has right of way. One-way traffic.

**NO** cell phone use, scavenging, children or pets out of vehicle, or smoking. No paints, tires, batteries, liquids, fuels, oils, or propane tanks, or electronic waste in your trash load. Special requirements and/or fees apply to these items.

 \*Slash , Stumps, and Pallets must be separate loads for lower rates – raw dimensional lumber only - no creosoted, painted, stained or treated lumber in clean lumber – no plywood or OSB. No trash or other construction debris. No metal hardware.  
 Contaminated loads charged at loose trash rate, along with applicable surcharges and additional hauling fees.
