Permit is invalid unless signed by an authorized agent of the Summit County Public Health Department.

Certified Personal Recreation businesses who receive a 5 Star Certification must operate within the following parameters:

- a. Business must operate in accordance with criteria outlined on page 2 of this document at all times.
- b. Business must follow the CDPHE COVID [Personal Recreation Guidelines](#).
- c. Business must operate at current capacity limits permitted and defined on the Summit County 5 Star webpage. www.summitcountyco.gov/5star
- d. If a county sees a significant rise in cases, percent positivity, or hospitalizations, then the program may be suspended. This automatically occurs if the region reaches more than 90% of their county's/RETAC ICU hospital capacity.
- e. If business is not following the requirements laid out in this permit, this permit may be revoked at the discretion of Summit County Public Health.
- f. A copy of this document must be visible to the public at the entrance of the business.
