Landfill/Trash items:

M-F 7:00 a.m. – 4:00 p.m., Sat. 7:00 am – 12 noon

All other Services: M-F 7:00 am – 3:30 pm

Closed: Sunday

Holiday Closures: New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving, and Christmas. Christmas Eve is usually a half day.

HIGH VISIBILITY SAFETY VEST REQUIRED VEST WILL BE PROVIDED FOR A FEE.

All hand unloaders need to be in 30 min. prior to closure.

ALL customers must be unloaded & out the gate by posted closing or double charges will apply.

Wind or lightning closures possible – call to verify.

SCALE PROCEDURE:

All vehicles must check-in at the scale house. Proceed slowly onto and off the scales.

Wait until you get the green light or vehicles to clear scale before driving on. Scale needs to zero between vehicles to get accurate weight.

Do not shift gears or come to an abrupt halt, this can damage the scales.

Shut down engine while speaking with the gatehouse technician.

One-way traffic and a **14.5 mph** speed limit throughout landfill. Landfill equipment has right of way.

No paints, tires, batteries, liquids, fuels, oils, propane tanks, or electronic waste in your trash load; specific requirements apply to these items.
